

Quilts Among the Pines – October 1-2, 2011
Pine Tree Quilters Guild, Wausau, WI

Entry Information: Retain this sheet for your records

1. **New location:** Patriot Center at Cedar Creek Mall (US39 exit 185 to Rothschild/Wausau, keep right on off-ramp (US 51 Business north), take 1st right at stop light onto Imperial Ave. Mall will be ahead on Market Street with Patriot Center at left)
2. **Division Changes:** Added “Gifts & Purchases”; deleted “Home Décor,” reorganized Divisions/Classes to focus on quilt-making as well as quilting, and added new sizes.
3. **Entry fees** are non-refundable and changed from last show:
 - a. PTQ members: \$2 for each entry up to 10; no add'l charge for #11 up
 - b. non-members: \$5.00 each for first 3 entries; \$3 each for 4-10; no chg for 11+
 - c. Youth (18 and under) entry fees: \$1.00 per entry.
4. **ENTRY FORMS** must be postmarked by **WEDNESDAY, AUGUST 31, 2011**.
Entry information is described in detail on page 3. One master form with name, address, list of quilts entered by title, division and class must be submitted along with payment; additional pages describing the quilt can be typed or handwritten & included, or emailed as an attachment; this may include pattern, history, design, motivation, coloring. This data will be included on the identifying label pinned to the quilt in the show.
5. **Definition** of a “quilt”: three layers consisting of a top, batting/filler, and backing held together by quilt stitching, tying or tacking. EXCEPTION is the “Other” Class (see definition). Note bags, totes, clothing must conform to this rule.
6. **Hanging sleeve** must be attached to the back and extending the full width of the quilt. Use a 4 inch rod pocket for quilts with an outside perimeter of 141 inches or more. Use a 3 inch rod pocket for smaller quilts and wall hangings. The top of the sleeve must be positioned 92 inches from the bottom of the quilt. If the quilt is still too long, it will be pinned up from the bottom.
7. **Quilt ID:** Each entry must have the entrant’s name and address secured to the back.
8. **Ineligible:** Entries in previous “Quilts Among the Pines” shows cannot be entered nor can entries soiled, damaged, or mounted in/under glass, or framed. Committee reserves the right to reject and refuse to exhibit entries.
9. **Reclassification of entries:** PTQ reserves the right to reclassify entries. If there is a question on the division or classification of a quilt, the Entry Committee will make the final decision. 1st, 2nd, 3rd and HM ribbons may not be awarded in every class.
10. Entries must be **delivered to the Patriot Center in Cedar Creek Mall, on Thursday, September 29th, 2011, between 6:00 pm and 7:30 pm OR Friday, September 30th, 2011, between 7:30 am and 8:30 am.**
11. For special arrangements, contact Angela Burger (715-845-1834 or email: drburger@dwave.net). Address shipped quilts to Angela Burger, 501 La Salle St., Wausau, WI 54403. Quilts shipped should arrive between September 17-23, 2011. Return shipping and insurance fees, a self-addressed shipping label and a sturdy reusable box must be supplied if the entry will not be picked up after the show on Sunday, October 2, 2011.
12. All entries must remain on display until 4:00 pm on Sunday, October 2, 2011. Pick up time is between 4 pm and 5 pm. CLAIM CHECKS WILL BE REQUIRED.

The PTQ Guild has taken measures to protect all entries. However, EXHIBITORS ARE URGED TO CHECK PERSONAL INSURANCE POLICIES FOR COVERAGE.
